



## Former IMCO Waste Disposal Area Collection

The former IMCO Waste Disposal Area site is located at 1462 Quarry Street in the City of Corona, Riverside County, California. The geographic coordinates for the site are 33°52'39.26"N latitude and 117°32'35.27"W longitude<sup>1</sup>. The former IMCO Recycling Facility waste disposal area comprises 2-acres of a 3.9-acre portion of undeveloped land located in a light industrial area of Corona, California ("the Site"). The Site is bounded by the Santa Fe Railroad property spur to the north and east, 6<sup>th</sup> Street to the south, and commercial properties to the west. Use of the commercial properties to the west include, but is not limited to: La Canasta Furniture, Honer Inc., Merrick Engineering Inc., Minka Lighting Inc., Penske Truck Rental, Hardwood Floor Galleria and Old World Classics. The downtown area of the City of Corona is located approximately 1.25 miles to the west of the Site. Highway Interstate 15 is located approximately 0.5 miles to the east of the Site.

In 1946, the Aluminum and magnesium Corporation operated a secondary scrap aluminum and magnesium smelter on the parcel adjacent to the Site. The smelter operation included recovery, processing and smelting of aluminum- and magnesium-bearing scrap to produce alloy products for sale. Waste materials from the smelter were disposed at the Site, which at the time was a portion of an abandoned gravel quarry. In 1967, Vulcan purchased the smelter facility. Between 1967 and 1996, the Site was permitted as a Class III solid waste disposal facility by the California Regional Water Quality Control Board – Santa Ana Region ("Regional Board") for inert waste. Waste materials were primarily concrete rubble. Since 1996 the Site has been vacant.

The Site owner, 6<sup>th</sup> and Radio Road Business Park II, LLC, entered into a Voluntary Cleanup Agreement (VCA) with Department of Toxic Substances Control (DTSC) on December 12, 2003 (Docket No. HSA-A 04/05-161). The goal of the VCA is to evaluate the risk to public health and the environment from chemicals of concern at the Site, and to ensure that the area is cleaned-up to levels acceptable for future industrial and commercial use under the oversight of DTSC<sup>2</sup>.
